

Contract regarding the career fair TEAM the 25th-26th of September 2018

You are about to make a registration for the career fair TEAM, referred to as the fair. Before the registration, it is required to read and approve the following contract. The registration is binding after the 21th of May 2018.

Definitions

The Student Association of Industrial Management and Engineering and the Business and Economics association ELIN at the University of Linkoping is referred to as the Organizer. The Organizer' contracting party is referred to as the Company. The Company is responsible for all material associated with the exhibition showcase.

The Organizer takes responsibility of surveillance in the exhibition area during the night to the 25/9-2018, in addition to the night between the both days of the fair.

Goods

The Company is responsible for collecting all goods associated with the exhibition before 12 pm the day after the fair unless an exception is agreed with the Organizer. For remaining goods, the Company will be charged an administrative fee, corresponding to the cost of storing the remaining goods. If transportation of goods between fairs is ordered, the fair sending the goods will engage an external party for the service. The Organizer is not responsible for the service provided by an external party.

Information and marketing

The Organizer do not take responsibility for errors occurring in texts/facts or errors occurring in advertisements submitted by the Company. If the advertisement is not submitted to the Organizer in the correct format or not within the due date, the Organizer is allowed to exclude information about the Company from the website.

Reports

The Company is obligated to report name and food preferences for the participating representatives of the Company, no later than two weeks before the fair, unless otherwise is agreed with the Organizer.

Payment

The payment must be made within 30 days from the invoice issuance, unless otherwise is agreed with the Organizer. The Organizer is entitled to invoice the Company's chosen fair-package in advance. The cost of the fair-package is 31'000 kr for two days of participation or 21'000 kr for one day of participation. For further information about prices, see attached file or email.

Payment delay

Cancellation

Cancellation by both parties can be made without charge before the 21/5-2018. If the Company completes a cancellation between the 22/5-2018 - 31/7-2018 the Company is charged an administration fee corresponding to half the fair-package chosen. If the cancellation is completed later than the 31/7-2018, the Company is charged full price of the fair-package. The price for the fair-package is 31'000 kr for two days of participation or 21'000 kr for one day of participation.

Grounds for relief

Following circumstances constitute grounds for relief, if these circumstances are preventing the contract to be fulfilled, and if the circumstances could not be foreseen when the contract was entered: All circumstances that the Organizer can not control, such as bankruptcy, fire, war, mobilization or military call of comparable scope, rebellion or riot. The part wishing to claim relief under the above mentioned reasons should immediately notify in writing to the other party of the occurrence of such grounds and in writing also inform about its cessation.

Controversy

Any dispute concerning interpretation or application of this Agreement and related matters shall be settled in the ordinary courts.
